

ORDINANCE NO. 17-20

AN ORDINANCE IN AMENDMENT OF SECTION 9-4 OF THE CODE OF ORDINANCES, TOWN OF NORTH KINGSTOWN, ENTITLED, “FEE SCHEDULE ENUMERATED – TABLE VI – RECREATION DEPARTMENT FEES – ALLEN HARBOR”

The Town Council of the Town of North Kingstown hereby ordains:

SECTION 1. That Section 9-4 of the Code of Ordinances, Town of North Kingstown, entitled, “Fee Schedule Enumerated – Table VI – Recreation Department Fees – Allen Harbor” is hereby amended as follows:

Yearly mooring and slip rentals require a nonrefundable deposit of \$250.00 to reserve space for the season.

Boat measurement entails the overall length of the boat including but not limited to any bow or stern extensions.

Late Fee pertains to the final payment in full for slips and moorings if payment is not received by the due date.

Clerk's Note: There are no changes to the North Kingstown Harbor Fees.

SECTION 2. This Ordinance shall take effect upon passage and all Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.
