3. SALE OF WICKFORD ELEMENTARY SCHOOL (Resolution of the Town Council adopted July 11, 2011)

"SHALL THE TOWN COUNCIL, IF IT DETERMINES THAT BONDS TO FINANCE RENOVATIONS FOR THE REUSE OF WICKFORD ELEMENTARY SCHOOL SHOULD NOT BE ISSUED, IN ACCORDANCE WITH SECTION 314 OF THE TOWN CHARTER, BE AUTHORIZED AND EMPOWERED TO EXCHANGE, ASSIGN, TRANSFER, SELL, LEASE, OR OTHERWISE CONVEY, UPON SUCH TERMS, CONDITIONS AND CONSIDERATION AS THE TOWN COUNCIL IN ITS SOLE DISCRETION SHALL DEEM FIT AND PROPER, SAID REAL ESTATE, COMMONLY KNOWN AS THE WICKFORD ELEMENTARY SCHOOL, OWNED BY THE TOWN AND LOCATED AT PHILLIPS STREET WHICH MAY BE DESCRIBED AS LOT 109 ON ASSESSOR'S PLAT 116?"
